**REQUEST FOR EXPRESSION OF INTEREST (REOI) FOR PREQUALIFICATION  
OF SUPPLIERS/VENDORS**

The Islamic Republic of Pakistan has received financing from the International Fund for Agricultural Development (“the Fund” or “IFAD”) and European Union (EU) towards the cost of Khyber Pakhtunkhwa Rural Economic Transformation Project (KP-RETP), and intends to apply part of the proceeds toward supporting Professional Farmers Cooperative Organizations (PFCOs) and Farmers Owned Agribusiness Hubs (FOAHs) in all districts of Khyber Pakhtunkhwa.

The use of any IFAD financing shall be subject to IFAD’s approval, pursuant to the terms and conditions of the financing agreement, as well as IFAD’s rules, policies and procedures. IFAD and its officials, agents and employees shall be held harmless from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any party in connection with KP-RETP.

The KP-RETP now invites EOI from eligible vendors/suppliers for pre-qualification to ensure timely and reliable provision of agricultural inputs to PFCOs and FOAHs. The eligible vendors/suppliers may submit their EOIs for pre-qualification for supply following categories of goods that will be required from time to time.

1. Seeds/Seedlings
2. Fertilizers
3. Agrochemicals/ veterinary medicines and supplies
4. Farm Machinery/ Technology

More details on submission requirements, evaluation criteria and other terms and conditions relevant to the process are provided in the Prequalification Document which can be downloaded from the official website i.e. <https://kpretp.gov.pk/tenders/>. It is important to note that incomplete, unsigned, or deficient applications/annexes will result in disqualification.

Please note that firms already qualified in any of the above categories need not reapply for the same category(ies).

A pre-application conference will be held on 08<sup>th</sup> April 2026 at 1100 Hours (PST) at the address given below.

The deadline for submission of applications for prequalification along with all relevant documents is **28<sup>th</sup> April 2026 at 1400 Hours (PST)**.
